Sealed tenders are invited through Single Stage-One Envelop bidding procedure, for leasing out MEPCO owned PC Pole Plant at Lodhran for a period of 3-years lease / contract period (one month will be maintenance period of each year) for manufacturing and supply of following quantities of Spun Hollow PC Poles according to WAPDA / PEPCO specification No. DDS-55-2006 (amended to-date) after installation of additional equipment / machinery required for manufacturing of all sizes of Spun Hollow Poles at the cost of manufacturer / firm on ex-pole plant basis on the rates in local currency without involving foreign exchange element exclusive of General Sale Tax.

- Quantities for manufacturing and supply of Spun Hollow PC Poles for 1st year is as under:-

a.	LT 31 Ft	12000-Nos.
b.	HT 36 Ft	12000-Nos.
c.	HT 45 Ft	3000-Nos.
- Quantities of Spun Hollow PC Poles for 2nd & 3rd year will be as per requirement of MEPCO for each year.
- The firms which are interested for obtaining lease / contract are required to furnish their offers as per following:

Additional equipment / machinery at MEPCO Owned PC Pole Plant Lodhran required for manufacturing of all sizes of Spun Hollow PC Poles as per above quantities will be installed by the firm at their own cost.

- i. Detail of machinery / equipment with its cost to be installed by the firm at its own cost for setting up of Spun Hollow Poles manufacturing facility may also be submitted with tender.
- ii. Time schedule for setting up of Plant, machinery / equipment and prototype testing / approval will be 90-days after signing of contract agreement.
- iii. Rate should be quoted on Ex-Pole Plant basis exclusive of GST and without involving foreign exchange.
- iv. Price Adjustment clause will be applicable for 2nd & 3rd years only.
- v. After completion of lease period, if further agreement not renewed, contractor can lift up only moveable machinery / equipment installed by them at their own risk and cost.
- vi. The machinery / equipment already installed at PC Pole Plant Lodhran by MEPCO shall be handed over to successful bidder and same shall be taken back in same condition after completion / termination of contract. However, if contractor requires to dismantle any part or whole of plant for manufacturing of Spun Hollow Poles, he can do so with prior approval of MEPCO but the same

shall be re-installed back in original condition at his own cost at the time of handing over the plant to MEPCO.

ELIGIBILITY FOR PARTICIPATION.

- Contractors / firms registered with Pakistan Engineering Council Islamabad for the year 2022-23 in category C-2 and above.
- Firms / pole manufacturer of Spun Hollow PC Poles running their own Pole plants duly pre-qualified / registered with WAPDA / PEPCO / DISCOs **OR** firms who are pre-qualified / registered with WAPDA / PEPCO / DISCO's, having at least 03-years proven satisfactory experience of manufacturing of PC Spun Hollow Poles are eligible.
- Firm / bidder should have minimum 03-years proven satisfactory completion experience in manufacturing of different sizes of Spun Hollow PC Poles.
- Firm / bidder should have valid & active registration in sales tax & income tax with FBR.
- Bidders / firms submit income tax statements of last 3 years.
- In case of Joint Venture, all the J.V partners shall jointly meet the requisite criteria with the lead partner or other partner(s) meeting not less than 50% and 20% respectively of the said criteria.
- Two or more J.V partners can apply jointly, a project of category higher than the category of their individual licences but sum total of limit of their individual category should be equal or higher than the requisite category.

Note:- The interested firms / bidders shall submit the above mentioned documents with application for issuance of tender documents and after scrutiny of documents provided, the tender documents will be issued to eligible firms / bidders.


The following documents / information shall be submitted along with tender documents.

- Name of Firm with Complete Address.
- Detail of manpower (permanent) with their qualification.
- Detail of completed works with satisfactorily completion certificate and manufacturing experience of PC poles with (PEPCO / DISCO's) / private pole plants.
- Valid Registration Certificate with Pakistan Engineering Council in relevant category.
- Income tax No and income tax statements of last 3 years.
- Average annual construction turn over for last 03-years.
- Proof of ownership of Spun Hollow PC Pole Plant with its location, if applicable.
- Active Sales tax registration certificate.
