TECHNICAL EVALUATION OF THE BIDS RECEIVED AGAINST TENDER NO. 17/GSC (2021-22) FOR CONSTRUCTION OF 132KV STEEL TUBULAR POLES / TOWERS FOUNDATION, ERECTION OF TOWERS / POLES, STRINGING WITH CONDUCTOR, TESTING & COMMISSIONING FOR 132KV NOOR SAR – BAHAWALNAGAR T-OFF QABULA T/LINE AT 132KV GRID STATION BAHAWAL NAGAR OLD UNDER MEPCO OWN RESOURCES.

1. INTRODUCTION:

- 1.1 Project Director GSC MEPCO Multan floated the Tender No. 17/GSC (2021-22) for construction of 132KV steel tubular poles / tower foundation, erection of towers / poles, stringing with conductor, testing & commissioning for 132KV Noor Sar – Bahawal Nagar T-Off Qabula T/Line at 132KV Grid Station Bahawal Nagar Old under MEPCO own resources on item rate basis under single stage two envelope bidding procedure (NCB) in accordance with provisions of PPRA Rules.
- 1.2 Technical bids of above said tender were opened on 25.01.2022 in the office of Chief Engineer (Dev.) PMU MEPCO in the presence of bidder's representatives and forwarded to Chief Engineer (O&M) Dist. MEPCO (Convener Tender Evaluation Committee) for Technical Evaluation vide Chief Engineer (Dev.) MEPCO Office Letter No.616-22 dated 25.01.2022.
- 1.3 Sub-Committee constituted by Chief Engineer (Dev.) vide office order No. 50/9258-68 dated 16.12.2021 for initial scrutiny, preparation of draft evaluation report and submit to main tender evaluation committee for consideration and approval.
- 1.4 This report only covers the technical evaluation of the bids for Tender No. 17/GSC (2021-22)

2. SCOPE OF WORK:

- 2.1 The scope of Tender No. 17/GSC (2021-22) comprises of following:

4. QUALIFICATION & EXPERIENCE:

As per clause 3 (a), (b) & (c) of NIT (Eligibility), bidders have to comply with Registration with PEC, Participation in at least two contracts having value of each contract exceed **Rs.07-Million** that have been successfully completed within last five years and that are similar to the proposed works (The bidder will submit completion certificate of the projects) & registration with PRA. The bidder must have income tax returns of last two years and also have turnover exceeds **10-Million** for last **three years**.

4.1 M/s M. Saeed Contractors Faisalabad:

a) Qualification & Experience
