1. INTRODUCTION:

- 1.1 Project Director GSC MEPCO Multan floated the Tender No. 20-21/GSC (2021-22) Tender No. 02 for construction of equipment foundations and allied works for 01 No. Line Bay at grid stations (i) 132KV grid station Noor Pur (ii) 132KV grid station Pakpattan (iii) 132KV grid station Fort Abbas under MEPCO own resources under single stage two envelope Bidding procedure (NCB) in accordance with provisions of PPRA Rules.
- 1.2 Technical bid of above said tender was opened on 01.02.2022 in the office of Chief Engineer (Dev) PMU MEPCO in the presence of bidder's representatives and forwarded to Chief Engineer (Q&M) Dist. MEPCO (Convener Tender Evaluation Committee) for Technical Evaluation vide Chief Engineer (Dev.) MEPCO Office letter No. 1001-07 dated 04.02.2022.
- 1.3 This report only covers the technical evaluation of the bid for Tender No. 20-21/GSC (2021-22) tender No. 02.

2. SCOPE OF WORK:

The scope of Tender No. 20-21/GSC (2021-22) tender No. 02 comprises of following work.

4. TECHNICAL DISCUSSION:

As per clause Eligibility clause (a to f) of NIT and clause 2.1 (a to g) of bid data sheet of bidding documents, the bidder must have registered with Pakistan Engineering Council with category C6 "specialization code CE10, valid for year 2021-22" and completed at least two (2) contracts within last ten years and that are similar to the proposed work (The bidder will submit completion certificate of the projects). Bidder also registered with Punjab Revenue Authority for provincial sales tax and submit income tax returns for last two years.

4.1 M/s Light Engineering Company Lahore

a) Qualification & Experience

M/s Light Engineering Company Lahore is registered with PEC (No. 3665) Category C-2 valid upto 30.06.2022 with specialization code CE-10 etc (validity online checked) and is involved in construction of power transmission lines and residential colonies as well as grid stations in Pakistan. The bidder attached CDR No. PO08534751 dated 31.01.2022 amounting to Rs. 200000/- issued by Mezan Bank Chungi Amar Sadhu Branch Lahore and ^{copy of} technical bid also not provided as mentioned by tender opening committee hence not qualified for further discussion and found **technically non-responsive**.

4.2 M/s A.S. Construction Company Multan

a) Qualification & Experience

M/s A.S. Construction Company Multan is registered with PEC (No. 25344) Category C6 valid upto 30.06.2022 with specialization code CE-10 etc (validity online checked) and is involved in construction of civil works and other engineering works. Bidder is also registered with Punjab Revenue Authority with active status also attached income tax returns for last two years. The bidder has attached Work Orders & completion certificates of below mentioned projects executed by the firm.
