- b) Participation in at least two contracts that have been successfully completed within the last ten (10) years and that are similar to the proposed scope of work mentioned in the bidding documents (The bidder will submit completion certificate of the projects along-with supporting documents like work order, contract agreement etc.).
- c) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d) Identity Card of Contractor / Managing Partner / Director of the firm.

ELIGIBILITY CRITERIA FOR TENDER NO. 5

- a) Pakistan Engineering Council valid certificate with at-least Category **C-4** having Specialization Code **CE-10** must be provided.
- b) The bidder should have sound financial status. The difference between current assets and short term liabilities should be positive. Minimum average annual construction turnover calculated as total certified payments received for contracts in progress or completed, within the last three (03) years should be equal to **PKR 70 Million.**
- Participation in at least one or two contracts that have been successfully completed within the last ten (10) years and that are similar to the proposed scope of work, where the value of the Bidder's participation exceeds PKR 30 Million in one or two contracts (The bidder will submit completion certificate of the projects along with supporting documents).
- d) In case of JV, all the JV partners shall jointly meet the requisite criteria with the lead partner or other partner(s) meeting not less than 40% and 25% respectively of the said criteria.
- e) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
