- MEPCO invites sealed bids on item rate basis under **Single Stage- Single Envelope** bidding procedure, from eligible firms under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY

- This Invitation for Bids is open to all Bidders complying the following requirements: -
- Pakistan Engineering Council valid certificate with at least Category **C-6** having specialization code **CE-10** must be provided.
 - Participation in at least two contracts that have been successfully completed within the last ten (10) years and that are similar to the proposed scope of work as mentioned above, (The bidder will submit completion certificate of the projects).
 - The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
 - Identity Card of Contractor / Managing Partner / Director of the firm.
 - Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
 - Income Tax Returns** for last two years.
 - In case of JV, all the JV partners shall jointly meet the requisite criteria with the lead partner or other partner(s) meeting not less than **40%** and **25%** respectively of the said criteria.
- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Project Director (GSC) MEPCO, Multan up-to 19.09.2022.**
- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of **Rs. 2000/ (Rupees Two Thousand Only).**

- All bids must be accompanied by a Bid Security amounting to **2% of the bid amount** in favor of **Project Director GSC MEPCO Multan** of any scheduled bank having rating A+ and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
 - The bids will be opened at the office of **Chief Engineer (Dev.) PMU MEPCO Multan** in the presence of bidders / bidder's authorized representatives who choose to attend the tender.
 - Tender rates and amounts should be filled in figures as well as in words. Tenders documents should be signed as per general directions given in the tender documents.
 - All the procurement will be done according to PPRA Rules-2004.
 - Conditional / Electronic Bid shall not be permitted.
 - The bids covering partial and incomplete work shall be rejected.
