- b) The bidder should have sound financial status. The difference between current assets and short term liabilities should be positive. Minimum average annual construction turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years exceeds **PKR 10 Million**.
- Participation in at least two contracts that have been successfully completed within the last five (5) years and that are similar to the proposed works, where the value of the Bidder's participation for each contract exceeds PKR 07 Million (The bidder will submit completion certificate of the projects).
