


MEPCO TENDER NOTICE

3. Interested Bidders may obtain bidding documents containing all necessary information from the address given below from **10:00 AM to 4:00 PM (Monday to Friday)**.
4. The bidder / manufacturer must have at least five (5) years manufacturing or supplying experience of similar equipment / material with the same or higher rating and capacity and three (3) years of successful continuous operational experience.
5. The Bidding Document, in English language may be purchased by the interested bidders from the date of publishing and on the submission of a written application to the address below up-to one day prior to opening date during office hours on the production of prequalification/ registration and sales tax registration number/other documents/proof. Cost of each tender form is **Rs. 3000/-** (Non refundable) per document or may be sent by courier service if requested by the bidder for an additional fee of **Rs.500/-**. No liability will be accepted for loss or late delivery, in case the document may be sent by courier service. **No tender document will be issued on the tender opening date.**
6. The bids be prepared in accordance with the instructions in the bidding documents must reach the Office of Chief Engineer (Development) PMU MEPCO, Khanewal Road MEPCO Headquarter, Multan Circle Building, Opp. R.C Cola Factory, MEPCO Multan on or before tender opening/receiving time mentioned as above.
7. The tender shall remain open for acceptance for 150-days from the tender opening date and must accompany Bid Guarantee / CDR not less than 2% of the quoted bid price, valid for 180-days, issued by any Scheduled Bank of Pakistan on Specified proforma.
8. All the procurement will be done according to PPRA Rules 2004.
