MEPCO invites sealed bids on **Single Stage-Two Envelope** bidding procedure, from eligible firms under National Competitive Bidding (NCB) basis in accordance with Provisions of PPRA Rules.

ELIGIBILITY

- This Invitation for Bids is open to all Bidders complying the following requirements: -
- a) Pakistan Engineering Council valid certificate with having Specialization Code **CE-10** must be provided.

- b) The bidder as a main contractor (as single entity or as JV partner) must have completed at-least two contracts of same nature of above mentioned scope of work within 10 years awarded by WAPDA / NTDC / DISCOs. (The bidder will submit completion certificate of the projects along-with supporting documents like contract agreement, work order, BOQ of the works etc.).
- c) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d) Identity Card of Contractor / Managing Partner / Director of the firm.
- e) Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- f) **Income Tax Returns** for last two years.
- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Project Director (GSC) MEPCO, Multan up-to 12.10.2023** for tender No. 1 to 4 and **13.10.2023** for tender No. 5 to 8.
- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of **Rs. 2,000/- (Rupees Two Thousand Only)** for each tender.
- All bids must be accompanied by a Bid Security of the following amount for each tender in favour of **Project Director GSC MEPCO Multan** of any scheduled bank having rating A+ and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
