## **ELIGIBILITY CRITERIA**

- > This Invitation for Bids is open to all Bidders complying the following requirements: -
- a) Pakistan Engineering Council valid certificate with at-least Category C-5 having Specialization Code CE-10 & EE-05 must be provided.
- b) The bidder shall be in the active tax payer list (ATL) and will provide income returns for last three years.
- The bidder must have completed at least two contracts of same nature along with its completion successfully as main contractor within Ten years awarded by <a href="https://www.wappda/ntoc.org/wappda/ntoc.">WAPDA / NTDC / DISCOs</a>. The consolidated value of these contracts <a href="must be more than 60%">must be more than 60%</a> of the estimated / B.O.Q.Cost.
- d) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- e) Identity Card of Contractor / Managing Partner / Director of the firm.
- f) Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- The average annual turnover with tax returns from FBR should be at least 1.5 times the BOQ amount for last three (03) years, verified from certified auditor and current month bank statement showing 25% balance amount of work in bank.
- Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of Project Director (GSC) MEPCO, Multan up-to 18.10.2024 for tender.
- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee of Rs. 3000/- (Rupees Three Thousand Only).
- All bids must be accompanied by a Bid Security of amounting to Rs. 720,000/- in favor of Project Director GSC MEPCO of any scheduled bank and shall be valid 28 days beyond bid validity. The bid shall be valid for 150 Days.
