- Pakistan Engineering Council valid certificate with at-least Category C-6 having Specialization Code EE-05 must be provided.
- The bidder shall be in the active tax payer list (ATL) and will provide income returns for last three years.
- The bidder must have completed at least two contracts of same nature along with its completion successfully as main contractor within Ten years awarded by <a href="https://www.warpen.com/
- d) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- e) Identity Card of Contractor / Managing Partner / Director of the firm.
- f) Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
- The average annual turnover with tax returns from FBR should be at least 1.5 times the BOQ amount for last three (03) years, verified from certified auditor and current month bank statement showing 25% balance amount of work in bank.
