

MEPCO TENDER NOTICE

1. Sealed tenders are hereby invited from contractors approved / registered by Pakistan Engineering Council minimum, which must be renewed for the Year (2024-25) having field specialization (EE 04 and EE 05 and CE 10) for the below mentioned works at Sr. No. 15. The contractor is bound to produce the documents in original & all copies must be duly attested including CNIC of the Contractor / Managing Partner / Director of the firm.
2. **The Tenders will be received in the office of Project Director Construction MEPCO Multan on 22-01-2025 up to 02:00 PM and each will be opened separately on same date after 30 minutes of the closing time of bids (02:30 PM) as per PPRA Rules**, in the presence of contractors or their authorized representatives having registered power of attorney, who may care to attend. The contractor shall attach with BOQ 03% earnest money of the bid in the shape of call deposit issued by schedule Banks in Pakistan or from a foreign Bank duly counter guarantee by a schedule Bank in Pakistan before issuance of each tender book **(Fresh CDR without limit of validity)**.
3. The rate quoted by less than 20% from analyzed calculated rates / previous approved tender rates, the contractor have to submit 05% of total bid as performance security in the shape of CDR within 15 days before approval of rates, in case of nonsubmission of 05% security within 15 days, the competent authority have rights reserved for cancellation of tender and 03% earnest money would also be forfeited, and no tender will be issued to default firm/contractor for further one year in PD Construction Directorate.
4. The 05% security will be returned to contractor on successfully completion of works, otherwise security & earnest money will be forfeited.
5. Tender can be obtained from O/O Project Director (Const.) MEPCO Multan on payment of **Rs. 2000/- (Non Refundable)** after publication of tender from **08:30 AM to 04:30 PM** (as per Govt. office timings if modified). No tender will be sold on the date of opening. Conditional tender will not be accepted. All rights reserved for cancellation of all, or part thereof of the bid by the competent authority at any stage.
6. All the proceeding of the tender will be observed according to PPRA rules.
7. Time period of rates shall remain one year (i.e. from the date of agreement / issued date of award letter of contract).
8. Tenders will be issued to only those firms who pre-qualified / enlisted with WAPDA/PEPCO/ DISCOS/NTDC/MEPCO (Approved contractors from the office of Chief Engineer (Dist:) Engineering WAPDA Lahore / Office of the Chief Executive Officer MEPCO for execution of the works according to WAPDA / PEPCO guidelines, SDI, SOP, Specifications and designs mentioned as above.)
9. The bidder must have completed any contract of similar nature successfully in WAPDA / NTDC / DISCOs, Government / semi Government and any other well reputed organization same nature of work Normal / Hilly Area as required. Value of contract shall at least be equal to 80% of the value of the contract for which the bid is **submitted with the completion certificate of contract**.
10. **The bidder must have attached the required documents with the tender, any document short or not found attached, the tender will be cancelled by the tender opening committee at the time of opening of tender.**
11. Bidder shall demonstrate **Cash or Cash Equivalents** equal to minimum 40% of the contract value and current contract commitments, **In this regard bidder shall provide the fresh bank statements of last one year (Uptodate)**.
12. Income tax returns for last 02 Years must be included and all contractors must be registered with PRA.
13. Electronic bid shall not be permitted.
14. Already working contractors in PD Construction MEPCO directorate are required to produce satisfactory performance certificate / No Objection Certificate from the concerned (relating to tender) construction Divisions for issuance of tender documents (This condition is not for new contractors overall working in Pakistan, for the same nature of work, they are required to produce the same documentation in original at least 03 days before the last date of issuance of tenders in order to verify documents from where they have been awarded works).
