

If your request for a debriefing is received within the 3 Business Days deadline, we will provide the debriefing within five (5) Business Days of receipt of your request. If we are unable to provide the debriefing within this period, the Standstill Period shall be extended by five (5) Business Days after the date that the debriefing is provided. If this happens, we will notify you and confirm the date that the extended Standstill Period will end.

The debriefing may be in writing, video conference call or in person. We shall promptly advise you in writing how the debriefing will take place and confirm the date and time.

If the deadline to request a debriefing has expired, you may still request a debriefing. In this case, we will provide the debriefing as soon as practicable, and normally no later than fifteen (15) Business Days from the date of publication of the Contract Award Notice.

6. STANDSTILL PERIOD

The Standstill Period lasts ten (10) Business Days after the date of transmission of this Notification of Intention to Award.

The Standstill Period may be extended as stated in Section 4 above.

7. TECHNICAL SPECIFICATION (GCC 26.1)

Material will be supplied as per NTDC specification DDS-11:2019 amended upto date.

04 sets of Technical Data/ Drawings as approved against Type test will be submitted with a certificate that your product will be as approved by NTDC against Type test.within 07 (seven) days of issuance of contract.

8. TERM OF DELIVERY:

As per Section VII (Schedule of Requirement) of Bidding document, Delivery schedule is 270days from the date of Contract Agreement on FCS basis at 132KV MEPCO Ware-House, Khanewal Road Multan.

9. TERM OF PAYMENT (GCC 16.1):

Payment for Goods and Services supplied from within the Purchaser's Country shall be made in Pak Rupee, as follows:

- Advance Payment: Ten (10) percent of the Contract Price shall be paid within forty (i) (40) days of signing of the Contract against a simple receipt and a bank guarantee for the equivalent amount and in the form provided in the bidding document or another form acceptable to the Purchaser.
- On Delivery: Eighty (80) percent of the Contract Price shall be paid on receipt of the Goods and upon submission of the documents specified in GCC Clause 13.



(iii) On Acceptance: The remaining ten (10) percent of the Contract Price shall be paid to the Supplier within fifty (50) days after the date of the acceptance certificate for the respective delivery issued by the Purchaser.
