Interested eligible bidders are requested to register themselves on EPADS & submit their documents on EPADS.
- The tenders will be opened publically in presence of bidders or their representatives who wish to attend
  on above mentioned date & time in the office of Chief Engineer (Development) PMU MEPCO
  Khanewal Road, Multan.

The electronic bids shall be submitted by using EPADS on or before the dates & time as mentioned above in the e-bidding document. Manual bids, shall not be accepted. E-Bids will be opened on the mentioned dates & time.

Tender shall remain valid for 120 days after the opening date. Bid Security/Guarantee in original for fixed amount mentioned in bidding documents in shape of Deposit-at-Call, Bank Draft, Pay Order & Bid Guarantee issued by any scheduled Bank of Pakistan valid for 150 days after the opening date of tender in favour of Chief Engineer (Development) PMU MEPCO Multan shall be submitted in an envelope clearly marked with tender No. & Title before the E-BID submission deadline in the office of Chief Engineer (Development) PMU MEPCO Khanewal Road, Multan, otherwise Bid will be rejected.
