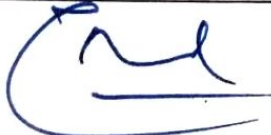

TENDER NOTICE

1. Sealed tenders are hereby invited approved / registered by Pakistan Engineering Council class A, B, C & D from contractors which must be renewed for the Year (2024-25) having field specialization (EE 04 and EE 05 and CE 10) for the below mentioned works at Sr. No. 13. The contractor is bound to produce the documents in original & all copies must be duly attested including CNIC of the Contractor / Managing Partner / Director of the firm.
2. **The Tenders will be received in the office of Executive Engineer (OP) MEPCO Division Shujabad on 13.10.2025 up-to 02:30 PM and each will be opened separately on same date after 30 minutes of the closing time of bids (03:00 PM) as per PPRA Rules**, in the presence of contractors or their authorized representatives having registered power of attorney, who may care to attend. The contractor shall deposit 02% earnest money of the tender amount in the shape of call deposit issued by schedule Banks in Pakistan or from a foreign Banks duly counter guarantee by a schedule Banks in Pakistan before issuance of each tender book.
3. The rate quoted by less than 20% from analyzed calculated rates / previous approved tender rates, the contractor have to submit 05 % of total bid as performance security in the shape of CDR within 15 days before approval of rates, in case of non submission of 05 % security within 15 days, the competent authority have rights reserved for cancellation of tender and 02% earnest money also would be forfeited.
4. The 05 % security will be return to contractor on successfully completion of works, otherwise earnest money i.e. 05% will be forfeited.
5. Tender can be obtained from O/O Executive Engineer (OP) MEPCO Division Shujabad on payment of **Rs. 2000/- (Non Refundable)** after publication of tender from 08:30 AM to 04:30 PM. Purchasing dated 12-10-2025 **No tender will be sold on the date of opening.** Conditional tender will not be accepted. All rights reserved for cancellation of all, or part thereof of the bid by the competent authority.
6. All the proceeding of the tender will be observed according to PPRA rules.
7. Time period of rates shall remain One Year (i.e. from the date of agreement), which can be curtailed / extended as per MEPCO requirement or till completion of bid amount, whichever is better in the interest of MEPCO.
8. Tenders will be issued to only those firms who pre-qualified / enlisted with WAPDA/PEPCO/ DISCOS/NTDC/MEPCO (Approved contractors from the office of Chief Engineer (Dist:) Engineering WAPDA Lahore / Office of the Chief Executive Officer MEPCO are invited for execution of the works according to WAPDA / PEPCO guide lines, SDI, SOP, Specifications and designs mentioned as above.)
9. The bidder must have completed 03 No. contracts of similar nature successfully with end user certificate in WAPDA / NTDC / DISCOs. Value of all contracts shall at least be equal to 80% of the value of the contract for which the bid is submitted.
10. Bidder shall demonstrate **Cash or Cash Equivalents** equal to minimum 40% of the contract value and current contract commitments, In this regard bidder shall provide the bank statements of last one year.

11. Income tax returns for last 02 Years and all contractor must be registered with PRA.
12. Performance Certificate/ No Objection Certificate must be required.
13. Electronic bid shall not be permitted.
