- The Multan Electric Power Company MEPCO ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of **Supply, installation, testing and commissioning of 13,323 Nos. APMS (Asset Performance Management System) on Distribution transformers of 100KVA & 200KVA Ratings** ("the Facilities").
- Open competitive bidding** (*international advertisement*) will be conducted in accordance with ADB's Single-Stage, One Envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
