



6. All prevailing Federal & Provisional Government taxes will be applicable.
7. Income Tax Returns for last three years will be required and all contractors must be registered with Punjab Revenue Authority as well as with FBR as active payer.
8. Contractors would provide on non judicial paper that their firms are not involved in litigation and not black listed by any Company / department duly attested by Oath Commissioner.
9. The successful Bidders shall deposit surety bond / bank guarantee issued by any Scheduled Bank of Pakistan amounting to Rs. 1,000,000/- (One Million) against each tender.
