- Lead all procurement tasks for equipment, supplies, and services necessary for MEPCO to succeed in its business
- Manage teams responsible for all inventory control and logistics of MEPCO for efficient and cost-effective distribution of equipment, supplies, etc., to be delivered to teams of other departments
- Ensure effective utilization of the ERP system of MEPCO for optimal supply chain execution
- Coordinate with other department heads to maximize effectiveness of supply chain and procurement functions
- Updates supply chain framework periodically and validate its alignment with internal business requirements and external (macro-economic) dynamics.
