 - c) The bidder must have completed at least two contracts of same nature along with its completion successfully as main contractor within Ten years awarded by WAPDA / NTDC / DISCOs. The consolidated value of these contracts must be more than 60% of the estimated / B.O.Q Cost.
 - d) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
 - e) The average annual turnover with tax returns from FBR should be at least 1.5 times the BOQ amount for last three (03) years, verified from certified auditor and current month bank statement showing **25%** balance amount of work in bank.
 - f) The contractor having two or more works in hand which are yet not completed and are beyond the stipulated time limit on the part of contractor, in GSC MEPCO will not eligible to participate in the tender.
