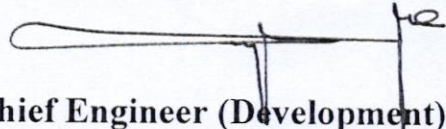

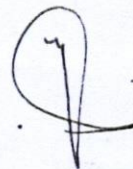

3. The following invitation of E-BIDS 2.0 are invited by adopting the Single Stage, Two Envelope bidding procedure as per PPRA Rules-2004 (Amended to-date) and is open to all potential bidders.
4. Interested bidders must be registered with EPADS 2.0 and shall submit their bids electronically through the EPADS portal before the prescribed closing date and time.
5. All bids must be accompanied by a Bid Security in an acceptable form of the amount mentioned against each bid.
6. Bidding documents containing detailed term & conditions, method of procurement, procedure of submission of bids, bid security, bid validity, evaluation criteria etc are available for the registered bidders on EPADS 2.0.
7. The tenders will be opened publically in presence of bidders or their representatives who wish to attend on above mentioned date & time in the office of Chief Engineer (Development) PMU MEPCO Khanewal Road, Multan.



8. The electronic bids shall be submitted by using EPADS 2.0 on or before the dates & time as mentioned above in the e-bidding document. Manual bids, shall not be accepted. E-Bids will be opened on the mentioned dates & time.
9. Tender shall remain valid for 120 days after the opening date. Bid Security/Guarantee in original for fixed amount mentioned in bidding documents in shape of Deposit-at-Call, Bank Draft, Pay Order & Bid Guarantee issued by any scheduled Bank of Pakistan valid for 150 days after the opening date of tender in favour of Chief Engineer (Development) PMU MEPCO Multan shall be submitted in an envelope clearly marked with tender No. & Title before the E-BID closing deadline in the office of Chief Engineer (Development) PMU MEPCO Khanewal Road, Multan, otherwise Bid will be rejected.
